Continuing Political Committees (known as CPC's or PACs) may contribute up to \$8,200 per election per candidate. A Partnership or LLC may contribute up to \$2,600 per partner or member per election, per candidate account, but must include a letter signed by each of the contributing partners or members specifically allocating the contributions. Vendors with certain public contracts may be subject to restrictions and/or reporting requirements pursuant to Monmouth County's pay-to-play resolution effective September 1, 2007. Any questions regarding such restrictions and/or reporting requirements should be directed to the contracting authority or your own legal counsel. Political contributions are not deductible for tax purposes. Please do not send cash contributions. New Jersey election law requires that we collect the name, address, occupation, employer and employer's address for every individual and report contributions in excess of \$300 to each of the above listed campaign accounts.
